- **+ SB 1009** appropriations; nuclear emergency management fund. Funds nuclear emergency preparedness, ensuring safety and readiness for Arizona.
- **SB 1027** critical telecommunications infrastructure; construction requirements. Imposes costly telecom construction mandates, burdening providers and delaying expansion.
- **SB 1050** GPLET; notice; abatement period. Cuts GPLET abatement period, impacting development incentives and economic growth.
- **+ SB 1144** jail facilities excise tax; extension. Extends jail excise tax twenty years to sustain vital public safety.
- + **SB 1222, HB 2688** internal revenue code; conformity. Aligns Arizona tax code with federal updates, simplifying compliance statewide.
- + **SB 1525** CTEDs; state universities; intergovernmental agreements. Expands CTED partnerships with universities, enhancing workforce training and opportunities.
- + SB 1534 ballot measure; description; legislative council. Improves ballot measure descriptions, ensuring voters receive clear, accurate information.
- + SB 1735 2025-2026; general appropriations act. Funds essential state services, supporting education, infrastructure, and public safety.
- + SB 1749 2025-2026; taxation; omnibus. Streamlines tax code, providing relief and clarity for Arizona taxpayers.
- + **SB 1750** transportation; 2025-2026. Invests in transportation infrastructure, improving safety, mobility, and economic growth.
- + **SCR 1041** expenditure limit; school districts; 2025-2026. Raises school district spending cap, supporting educational programs and student success.
- + SCR 1042 expenditure limitation; school districts; 2026-2027. Extends higher school spending cap, sustaining quality education and student achievement.
- + HB 2119 model city tax code; notice. Improves tax code transparency, giving businesses clarity and predictability statewide.
- + HB 2201 wildfire mitigation planning; utilities; approval. Strengthens wildfire prevention by requiring utility mitigation plans and oversight.
- + HB 2679 power; public utilities; UCC; securities. Updates utility regulations, supporting infrastructure investment and long-term service reliability.
