### **1 LOWERING THE COST OF DOING BUSINESS**

For Arizona to position itself for a stronger economic future, government should enhance economic activity and reduce the costs of doing business. State policies should provide a consistent and predictable environment to promote business growth and should not exceed federal requirements. Tax policy must enhance the business environment to promote job growth, diversification and business expansion.

### **2 BUILDING A TRAINED WORKFORCE**

East Valley businesses need a skilled and educated workforce as they respond to and prepare for continued innovation and automation. A demand-driven design of career pathways for students and workers is essential in filling the skills gap, retaining talent, and building the talent pipelines in alignment with our businesses. Due to the expansion and contraction of occupations and industries in the East Valley, lifelong learning is needed to obtain new and necessary skills throughout a career, which may include a combination of certifications, credentials and micro-credentials, and degreed opportunities. Additionally, a realignment in learning modalities is needed as students, educators, and employers discover the benefits of varied, personalized educational experiences and platforms.

### **3 INCREASING PRIVATE SECTOR JOBS**

Long-term economic competitiveness is critical to Arizona's success. Business revenues drive job growth and government budgets. Arizona must implement policies to position itself to be the state of choice for relocating and growing companies, which includes a vibrant education system. Future emerging technologies regulations must not place undue harm on the current business environment.

### **4 EFFICIENT AND EFFECTIVE GOVERNMENT**

Streamlined, transparent and improved government processes are crucial to the success of Arizona and its businesses. Government decisions are best left to those closest to the governed unless detrimental to the business climate. Initiative reform that reflects the will of Arizona citizens and businesses, not out-of-state interests, as well as public pension reform will create efficiencies and help restore the public's faith in government.

# The Alliance Priorities

The following legislative priorities outlines a variety of issues that directly impact the ability of East Valley companies to grow their businesses. These statements hold true at many levels of government. The Alliance is an organization that advocates a united voice at the State and Federal levels through collaborative efforts with Dorn Policy Group, Inc. Each Chamber individually advocates at their local municipal level and this document is not designed to supersede the local chamber's ability to do so. It is a shared outline of important matters that affect East Valley businesses. The Alliance supports:

## **ECONOMIC DEVELOPMENT**

Creative and appropriate solutions to attainable housing while maintaining local control over zoning and land use decisions. Municipal and state economic development plans, through local planning and zoning processes, respect the private property rights of owners and ensure that General Plans are implemented as adopted.

## **PROTECTING EMPLOYER'S WORKPLACE POLICIES**

Arizona's status as a "right-to-work" and "employment-at-will" state.

## **EDUCATION**

Securing the statutory authority from the Arizona Legislature to allow reauthorization of the Regional Transportation Plan.

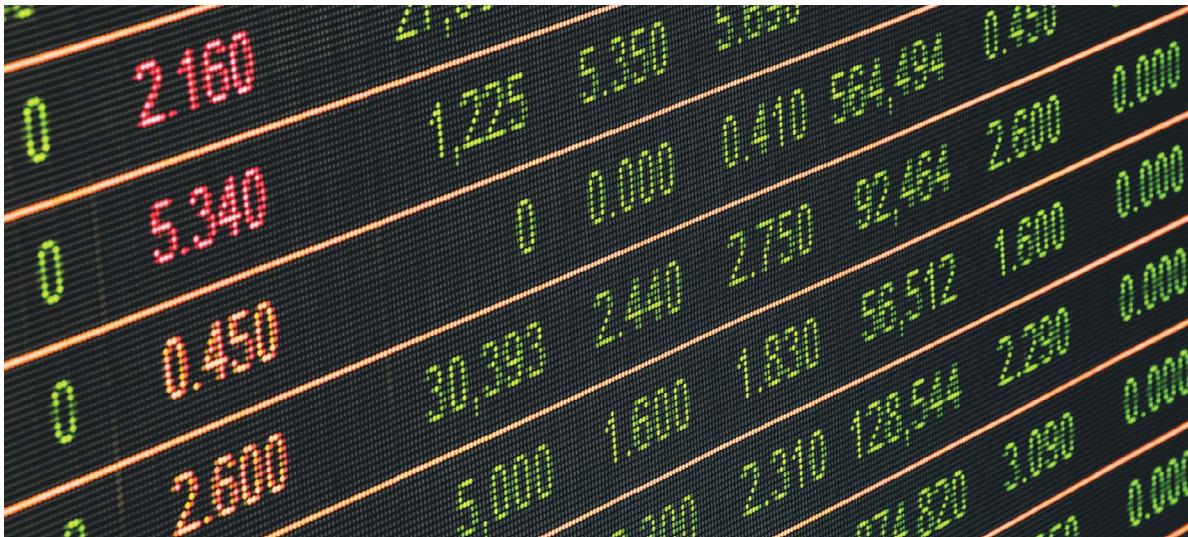

# Election Reform

  - Establishing regional requirements for signature collection in comparable proportions to that of statewide offices allowing for broad-based consensus amongst the electorate.-
  - Requiring Legislative Council to review and title initiatives prior to signature collection.
- A referendum suspending automatic spending increases for voter-protected funds in a fiscal year when revenues do not meet projections.

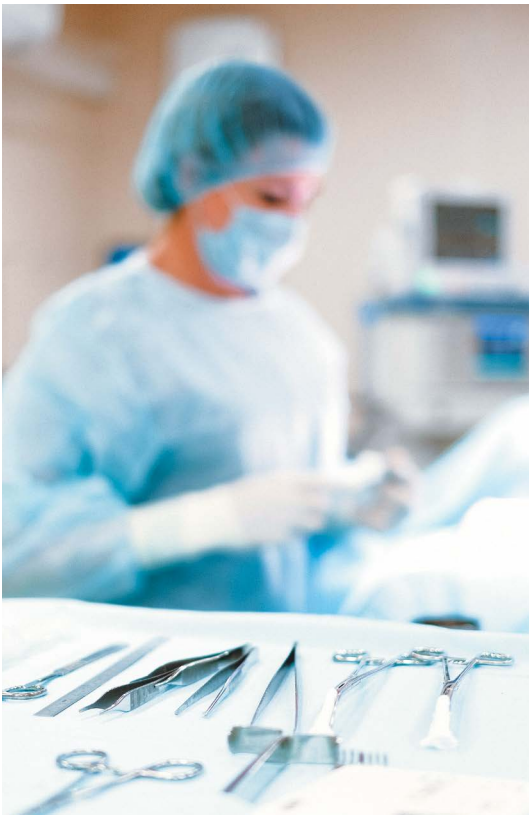

  - Offers a secure, reliable system for employers to verify the legal work eligibility of employees that is a federally based, user-friendly, low-cost, non-discriminatory method to ensure they are complying in good faith with the law.
  - Establishes a market-based immigration process to support a wide range of workforce needs and to respond quickly to the employment demands of U.S. businesses.
  - Develops criteria and establishes a guest worker/visa program for illegal immigrants already in the U.S. with no other criminal or arrest record in both the U.S. and their countries of origin, which is based on strictly enforced criteria, including payment of penalties.
  - Reimburses states for the costs of incarcerating, educating and providing health care for individuals in the country illegally.

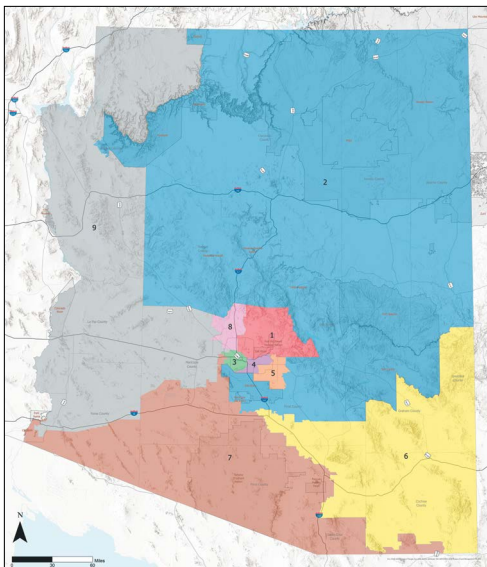

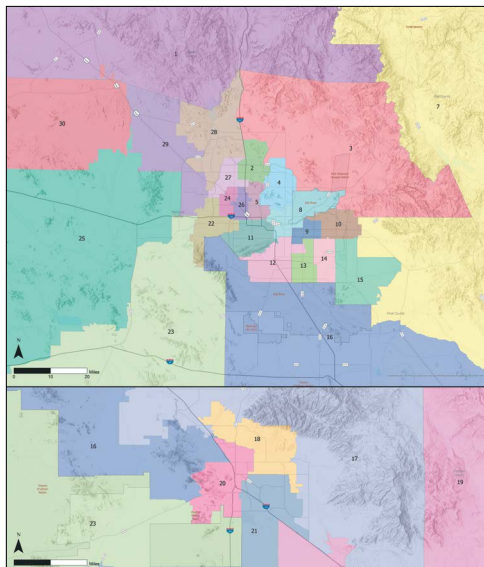
