# **VOTE YES** ON PROPOSITION 462 TO SECURE AN AFFORDABLE ENERGY FUTURE



For more than 35 years, Southwest Gas has proudly served Gilbert's residents and businesses with safe, affordable and clean natural gas. In 1997, citizens of Gilbert voted to approve a franchise agreement with Southwest Gas to guide the utility's work within the town. With that agreement set to expire, Mayor Brigette Peterson and the Gilbert Town Council have unanimously approved and referred a new agreement, known as Prop 462, to voters for their consideration. Passage of Proposition 462 will continue the mutually beneficial relationship between the Town of Gilbert and Southwest Gas and ensure residents continue to realize important benefits including:

#### Access to Affordable Energy

Ensures Gilbert has consistent access to balanced energy options, including affordable and clean natural gas.

#### **Accountability for All**

Establishes the rules of the road and holds Southwest Gas accountable to working within the rules established by the Town of Gilbert.

### Community Investment for Gilbert

Provides the Town of Gilbert with a revenue stream to support public safety, streets, parks, facilities and economic development.

# EXTENDS THE PARTNERSHIP BETWEEN GILBERT AND SOUTHWEST GAS

If Prop 462 is ratified by the voters, Southwest Gas will retain non-exclusive rights to use streets, alleys and other public places to serve current and new customers in Gilbert. In exchange, Southwest Gas will provide Gilbert an annual payment equal to 2% of the gross revenues that the company generates within the town. These funds will help support critical town services like public safety, road repair and parks and recreation programs.
